SUBJECT: Coghlin Park Floating Dock – Recommendation of Award

DESCRIPTION

In March of 2018 the city applied for a Michigan Department of Natural Resources (MDNR) Waterways Grant for the construction of a new 129' floating dock with finger piers of 3 varied lengths of 16', 24' and 30' at Coghlin Park. The total project cost was estimated at \$180,000. The city was awarded the grant from the DNR. The grant is a 50/50 matching grant. The project was bid out and two bids were received. The City's engineering firm has reviewed the bids and is recommending the Council award the bid to Meeco Sullivan in the amount of \$170,977.00.

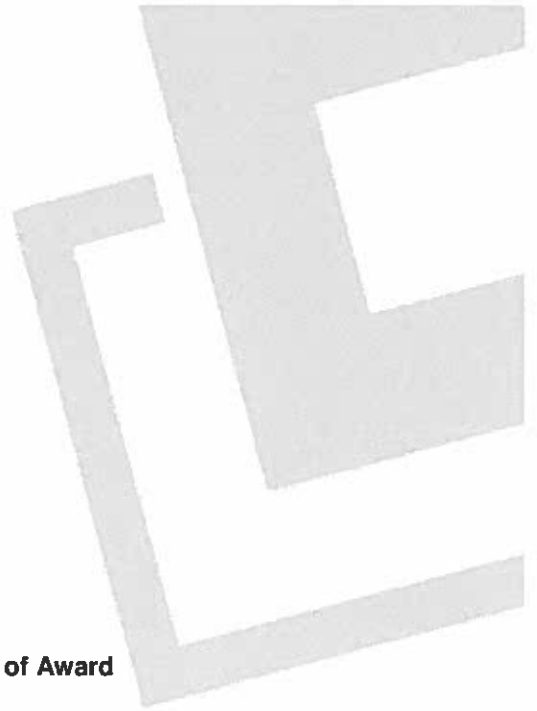

Arbor Day Foundation Names Saugatuck Tree City USA

Saugatuck, MI, was named a 2018 Tree City USA by the Arbor Day Foundation in honor of its commitment to effective urban forest management.

Saugatuck achieved Tree City USA recognition by meeting the program's four requirements: a tree board or department, a tree care ordinance, an annual community forestry budget of at least \$2 per capita and an Arbor Day observance and proclamation.

"Tree City USA communities see the impact an urban forest has in a community first hand," said Dan Lambe, president of the Arbor Day Foundation. "Additionally, recognition brings residents together and creates a sense of community pride, whether it's through volunteer engagement or public education."

Trees provide multiple benefits to a community when properly planted and maintained. They help to improve the visual appeal of a neighborhood, increase property values, reduce home cooling costs, remove air pollutants and provide wildlife habitat, among many other benefits.
